| Step 1 | Submit Retrofit Lighting Workbook PRIOR to installation along with all other necessary documents. | Purchase and install eligible measures(s) | Purchase and install eligible measures(s) |
| Step 2 | Purchase and install eligible measure(s) AFTER approval by Santee Cooper | Submit New Construction Lighting Workbook along with all other necessary documents. 14 days to review and additional 2-3 Weeks to receive rebate check | Submit Rebate Application along with all other necessary documents. 14 days to review 2-3 Weeks to receive rebate check |
| Step 3 | Submit Installation Notice and final Lighting Workbook. Receive Rebate Check within 2-3 Weeks | | |
